

## **RESOLUTION 2025-03**

### **A RESOLUTION DECLARING UNOPPOSED CANDIDATES ELECTED TO OFFICE.**

**WHEREAS**, the City Council of the City of Levelland, previously called for the general municipal election to be held on May 3, 2025, through City Council action approved Resolution 2025-03 on January 6, 2025, with early voting to be conducted from April 22, 2025 and ending April 29, 2025, for the purpose of electing the following officials:

One Councilmember to the City Council from District B and,  
One Councilmember to the City Council from District D and,

**WHEREAS**, the Resolution 2025-01 provided that applications for a place on the ballot for said election could be made beginning January 15, 2025 and ending February 14, 2025, and

**WHEREAS**, pursuant to Texas Election Code Section 2.052 the City Secretary of the City of Levelland has certified that only one candidate's name is to be placed on the ballot for the offices named below:

District B: Max Ledesma

**WHEREAS**, the filing deadlines for placement on the ballot and declaration of write-in candidacy have passed; and

**WHEREAS**, pursuant to Texas Election Code Section 2.053(a), the City Council of the City of Levelland shall declare any and all unopposed candidates elected to office; and,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LEVELLAND, TEXAS:

**Section 1:** Pursuant to the authority granted in Texas Election Code § 2.053, the following candidates are hereby declared to be elected to the following offices:

Councilmember District B: Max Ledesma for a full two-year term.

**Section 2:** The ballots used for the general municipal election on May 3, 2025, by City Council Resolution 2025-01, shall include Max Ledesma as an "Unopposed Candidate Declared Elected" to Levelland Council Member District B.


**Section 3:** A certificate of election shall be issued to Max Ledesma as elected to Levelland Council Member District B in the same manner as provided for a candidate elected at the election.




