

RESOLUTION NO. 2025-08

AN RESOLUTION CANVASSING THE RETURNS OF THE REGULAR MUNICIPAL ELECTION HELD WITHIN THE CITY OF LEVELLAND ON THE 3RD DAY OF MAY, 2025, FOR THE PURPOSE OF ELECTING COUNCIL MEMBER, DISTRICT B, AND COUNCIL MEMBER, DISTRICT D; AND CANVASSING THE RETURNS OF THE SPECIAL MUNICIPAL ELECTION HELD WITHIN THE CITY OF LEVELLAND ON THE 3RD DAY OF MAY, 2025, FOR THE PURPOSE OF ADOPTING OR REJECTING PROPOSED AMENDMENTS TO THE LEVELLAND, TEXAS, HOME RULE CITY CHARTER; DECLARING THE RESULTS OF THE ELECTION; FINDING THAT NOTICE OF THE ELECTION WAS DULY AND PROPERLY GIVEN, THAT THE ELECTION WAS PROPERLY HELD AND RETURNS THEREOF MADE BY THE PROPER OFFICIALS IN ACCORDANCE WITH THE LAWS OF THE STATE; CONTAINING A SEVERABILITY CLAUSE; CONTAINING A REPEALING CLAUSE; CONTAINING AN OPEN MEETINGS CLAUSE; AND PROVIDING AN EFFECTIVE DATE

WHEREAS The regular municipal election of the City of Levelland, Texas, for election of Council Member, District B, and Council Member, District D as prescribed by Article V of the City Charter and applicable state law, was lawfully called by Resolution 2025-01; and

WHEREAS The candidate for Council Member, District B, Max Ledesma, was unopposed and declared elected to office by Resolution 2025-03; and

WHEREAS The regular municipal election of the City of Levelland, Texas, for election of Council Member, District D as prescribed by Article V of the City Charter, was held on the 3rd day of May 2025, in the city, for the purpose of electing Council Member, District D; and

WHEREAS the City Council of the City of Levelland, Texas, after considering the recommendations of the 2025 Charter Review Committee of Levelland, did on its own motion by Ordinance No. 1088 submit to the qualified voters for adoption or rejection certain proposed amendments to the existing Home Rule Charter of the City of Levelland, Texas, pursuant to Section 9.004(a) of the Texas Local Government Code; and

WHEREAS the election was held on the 3rd day of May 2025 under and pursuant to the provisions of the resolution calling the general election and ordinance calling the special election, respectively; and

WHEREAS the elections having been duly and regularly held as called and provided in the ordinances and according to law, and the returns thereof having been made and the election judges having certified the results of the election, as hereinafter set out, and the City Council having duly and regularly canvassed the returns of the election and finding that the total votes cast at the election were as follows:

WHEREAS the City Council of the City of Levelland, Texas finds that the election returns set out above to be accurate and correct.

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF LEVELLAND, TEXAS, THAT:

SECTION 1: Max Ledesma was an “Unopposed Candidate Declared Elected” for the office of Council Member, District B, and, accordingly, Max Ledesma is declared elected to the office of Council Member, District B, subject to the taking of his oath as provided by the laws of the State of Texas.

SECTION 2: Michael Stueart received a majority of the votes cast at the election for the office of Council Member, District D, and, accordingly, Michael Stueart is declared elected to the office of Council Member, District D, subject to the taking of his oath as provided by the laws of the State of Texas.

SECTION 3: Each of the proposed Charter Amendments No.1-27 received a majority of the votes cast at the election in favor of adoption, and, accordingly, each of the amendments is adopted and the City of Levelland, Texas, Home Rule Charter will be so amended.

SECTION 4: The City Council of the City of Levelland, Texas finds that the notice of the election was duly and properly given as required by law and as provided in the ordinance calling the election, and that the election was duly and regularly held, and the returns thereof duly and regularly made by the proper officials of the election, and in all things according to the law.

SECTION 5: Each and every provision, paragraph, sentence and clause of this resolution has been separately considered and passed by the City Council of the City of Levelland, Texas, and each said provision would have been separately passed without any other provision, and if any provision hereof shall be ineffective, invalid or unconstitutional, for any cause, it shall not impair or affect the remaining portion, or any part thereof, but the valid portion shall be in force just as if it had been passed alone.

SECTION 6: All resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict only.

SECTION 7: The City Council of the City of Levelland, Texas officially finds, determines, recites, and declares that a sufficient written notice of the date, hour, place, and subject of this meeting of the City Council of the City of Levelland, Texas was posted at a place convenient to the public at the City Hall of the City for the time required by law preceding this meeting, as required by the Open Meetings Act, Chapter 551, Texas Government Code; and that this meeting has been open to the public as required by law at all times during which this resolution and the subject matter thereof has been discussed, considered, and

formally acted upon. The City Council of the City of Levelland, Texas further ratifies, approves, and confirms such written notice and the contents and posting thereof.


SECTION 8: This resolution shall be in effect immediately upon its passage and approval.
