FIRST ITEM OF BUSINESS:

Presentation by the South Plains Community Action Association about SPARTAN Transportation.

THIRD ITEM OF BUSINESS:

Consider and take necessary action to approve a Special Event Application for the Wallace Theater.

The Wallace Theater Grand Opening, "A Red Carpet Affair", is scheduled for Saturday, September 20th. The City's Special Events Committee has reviewed their application and their request to close a portion of Avenue H between Studebakers and the Wallace Theater, and has approved the application. The event plans to sell/serve alcohol. Per Section 4.1304 (h) For events that will be held on municipally owned property that will also involve the sale or service of alcoholic beverages, the permit application must also be approved by the city council.

FOURTH ITEM OF BUSINESS:

Consider and take necessary action on the request by Levelland Fire Department to donate excess and/or outdated rescue equipment to the Texas A & M Forest Service Helping Hands organization.

In 2008 the Levelland Fire Department applied for a grant from Homeland Security for rescue equipment to form the South Plains Regional Rescue Team. The city was awarded the grant, and the terms were to maintain the equipment for 10 years, then it would become property of LFD. We will have to document in our files if we destroy or pass the equipment along to another Agency because it is out of service. We received rope rescue, water rescue, confined space rescue, and structural collapse rescue equipment along with training to support these rescues.

LFD has contacted Sundown Volunteer Fire, Whiteface Volunteer Fire, and Morton Volunteer Fire and each entity has stated they could use this equipment in their respected districts. They will also support LFD in an incident. SVFD, and MVFD have 3 trained personnel and WFVFD have 4 trained personnel.

The city purchased 4 harnesses, helmets, 2 x 600 ft rope and 2 x 300 ft of rope with ARPA funds and have on order 4 more harnesses and helmets. LFD will add equipment to the budget a little each year on a rotation basis.

The Texas A & M Forest Service Helping Hands Program allows donations of new and gently-used fire and rescue equipment, fire trucks, and other items to be made available to fire departments throughout the state, while providing liability relief to the donor. The program routinely receives donations of structural gear, fire hoses, nozzles, rescue tools,

ladders, ventilation fans, and other items that are essential to the operation of a fire department.

Donations are vital to meeting the needs of volunteer fire departments, and we are grateful to our donors for their participation in supplying equipment through this program.
