**SECOND ITEM OF BUSINESS:**

*Hold a public hearing on the proposed fiscal year 2025/2026 budget.*

**THIS BUDGET WILL RAISE MORE REVENUE FROM PROPERTY TAXES THAN LAST YEAR'S BUDGET BY \$274,816, WHICH IS A 4.00 PERCENT INCREASE FROM LAST YEAR'S BUDGET, AND OF THAT AMOUNT \$86,093 IS TAX REVENUE TO BE RAISED FROM NEW PROPERTY ADDED TO THE TAX ROLL THIS YEAR.**

**FOURTH ITEM OF BUSINESS:**

*Consider and take necessary action to approve Resolution No. 2025-14 adopting the Fiscal Year 2025-2026 City of Levelland Budget.*

One of the many steps that the City needs to take in order to adopt a budget is to hold a public hearing on the proposed budget. The vote on the proposed fiscal year 2025-2026 budget is scheduled for September 15, 2025, after the public hearing.

Over the past several months city staff and Council have worked through the budget process and have developed the proposed FY 2025-2026 budget. It is now time to take official action on the proposed budget. The resolution following this memo will allow Council to adopt the proposed FY 2025-2026 budget. Be aware, this must be a record vote meaning that the City Secretary will ask each individual City Council member how he or she votes individually.

Since the 2025-2026 Budget is reflecting a total property tax revenue from the previous year, Texas Local Government Code 102.007(c), states that City Council must also take a separate ratification vote for the budget adoption.

**FIFTH ITEM OF BUSINESS:**

*Consider and take necessary action to ratify the property tax increase reflected in the proposed Fiscal Year 2025-2026 City of Levelland Budget.*

Since the 2025-2026 Budget is reflecting a total property tax revenue from the previous year, Texas Local Government Code 102.007(c), states that City Council must also take a separate ratification vote for the budget adoption.

**SIXTH ITEM OF BUSINESS:**

*Consider and take necessary action to approve Ordinance No. 1099 setting the 2025/2026 tax rate by setting the Maintenance and Operation component of the 2025/2026 tax rate (General Fund and Cemetery Fund) and the Debt component of the 2025/2026 tax rate. (Interest and Redemption Fund)*

The city's property tax provides approximately \$3.8 million to the General Fund. The Property tax is measured by the value of a taxpayer's property. It is also called ad valorem tax, a Latin phrase meaning "according to value." Our property tax rate is made up of two parts, an interest and sinking rate (otherwise known as the debt service rate) and a maintenance/operations rate (this funds the daily operations of the city). The proposed tax rate for FY 26 is .555000/\$100 valuation, maintenance/operations is .4785000/\$100 valuation, the Cemetery Fund receives .03/\$100 valuation and interest/sinking (debt service)

is .046500/\$100 valuation. The No New Revenue tax rate is .536706/\$100 valuation. One penny of property tax generates approximately \$76,000.

The proposed interest/sinking (debt service) rate for FY 26 is .0465/\$100 valuation. This is an increase of .010229.

Staff has also proposed increasing the Wastewater Improvement Fee from \$21.62/ month to \$28.00/month. The WWTP construction bid is \$26,265,000. This amount is approximately \$6,615,000 higher than projected. This fee will need to be reviewed in 3 years to determine if there is an additional increase needed to pay the debt service and to provide reserve funds within the Wastewater Fund. The projected Fund Balance for the Wastewater Improvement Fund at the end of FY 25 is approximately \$20,847,367 (this balance includes funds from the Certificate of Obligations). City Council approved this fee increase on August 25, 2025.

Staff has also proposed to increase the Water Improvement Fee from \$1/ month to \$5.00/month. The adjustment is due to new water treatment costs from the City of Lubbock. The projected Fund Balance for the Water Improvement Fund at the end of FY 25 is approximately \$299,570. City Council approved this fee increase on August 25, 2025.

The 2022 Certificate of Obligation series (original WWTP construction bond), and the 2025 Certificate of Obligation series (additional WWTP construction costs) have an estimated annual payment of \$2,070,575. The city has approximately 5200 active utility accounts;  $[5200 * \$28.00 = \$145,600 \text{ /month}; \$145,600 * 12 = \$1,747,200]$ . The city receives approximately \$320,000/year from the sale of effluent water.  $[\$1,747,200 + \$320,000 = \$2,067,200]$  This leaves a shortfall of \$3,375. We will utilize WW Improvement Fee funds (reserve funds) to cover the difference. Once the WWTP comes online (Winter 2026), we will review our financial status at that time.

The City Council authorized the issuance of the Certificates of Obligation for the Wastewater Treatment Plant Construction (additional funds) and for the Animal Services Facility (Animal Shelter) on Monday, August 25th.

\*\*\*25% of the Series 2025 CO Debt Service for the WWTP is paid for with I & S taxes.

\*\*\*\*The city has an additional \$516,000 annual payment in Utility Revenue Supported Debt Service due to the issuance of debt for the replacement of water meters. The funds to pay this debt will come from recovered revenue due to inefficient meters.

To approve and adopt Ordinance No. 1099, and that the property tax rate be increased by the adoption of a tax rate of \$0.55500, which is effectively a 3.74% percent increase in the tax rate with the components of the tax rate being as follows:

Maintenance and Operations - General Fund \$0.478500; Cemetery Fund \$0.03;  
Debt - Interest and Redemption Fund \$0.046500

**SEVENTH ITEM OF BUSINESS:**

*Consider and take necessary action on a transfer and assumption agreement with Covenant Ambulance Service.*

Newman Wheeler, Chief Administration Officer for Covenant Hospital- Levelland, reached out to us. He indicated that Covenant has internally reorganized their region Ambulance services to all one department, it requires them to transfer all ambulance contracts to same department. The internal change does not change any operational responsibilities they currently have or will have in the future. Ownership is still Covenant Health.

This agreement is simply the paperwork that goes along with that sort of reorganization.

To approve a transfer and assumption agreement with Covenant Ambulance Service.
