FOURTH ITEM OF BUSINESS:

Discussion of Board Appointment process.

Volunteers serve a vital role in our community and are a great resource for our Boards & Commissions. Council has been provided with a list of our boards and the expiring terms of members. On that list, we have noted the board members who are willing to continue to serve should Council wish to re-appoint.

Something to be aware of—

In 2021, Council approved Resolution 2021-57, instilling term limits for our boards and commissions. Term limits were set at two consecutive terms per board member per board. At that time, the term limit “timer” started upon the next appointment. Fast forward to today: We will see the first board member term limits in 2026.

No Action Taken

FIFTH ITEM OF BUSINESS:

Consider and take necessary action to approve staff holidays for the 2026 calendar year.

The City of Levelland 2026 Holiday Schedule is included for your review and consideration of adoption.

According to the Federal Office of Personnel Management, there are eleven annual U.S. federal holidays on the official 2025 calendar: New Year's Day, Birthday of Martin Luther King, Jr., President's Day, Memorial Day, Juneteenth National Day, Independence Day, Labor Day, Columbus Day, Veterans Day, Thanksgiving Day and Christmas Day. The City of Levelland does not close for President's Day, Juneteenth, Columbus Day or Veterans Day.

In addition to the 7 federal holidays, the city closes for Good Friday, the day after Thanksgiving and for Christmas Eve. Finally, the City has allowed each employee 2 Floating Holidays to use as they please, with the intention of staff being able to celebrate a federal holiday that is not recognized by the City, or simply utilizing that day as a personal day.

In 2026, New Year's Day will fall on Thursday, respectively. I would like the City Council to consider moving one floating holiday for 2026 to Friday, January 2nd. That would allow holiday time for 11 City holidays" and 1 floating holiday.

City Manager Report: Staff Updates, Project Updates, Staff/Citizen recognition, Items of Community Interest. No action will be taken.

- LCDC will be meeting tomorrow at 6 pm to consider approval of the audit and hold a Public Hearing for FY 26 projects.
- SPAG Open House is Thursday, October 23rd from 1 – 4 pm. If you would like to attend, please contact Andrea.
- Ribbon cutting for the restoration of the Home of the Loboette State Championship sign is Friday, October 24th at 10 am, corner of Alamo Road and SH 114.
- Centennial Committee is meeting on Monday, October 27th at 5:30 pm here at City Hall.
- SPC Creative Arts 50th Anniversary Celebration is October 30th – November 1st on campus.
- Trunk or Treat is at SPC campus on Friday, October 31st from 6 pm 8 pm at the Track Parking Lot, sponsored by Levelland Noons Lions Club.

- Construction news: Maverick Bank is shooting for an opening date of March 1st; 7 Brew is anticipating opening early November; Take 5 Oil is set to open early February; Whataburger is looking at mid-February for opening; and the Circle K should be breaking ground by mid-November.
- City staff is reviewing apps that will serve as a one-stop shop for residents, customers and employees. Besides being able to view water usage, we are hoping to create the ability for notifying of potholes, weeds, signage, etc, and for notification for utility bills or emergencies. Staff will utilize the ICMA and TML Conferences to get more information.
- The city has completed an agreement with Circle K for the pavement of concrete on the interior lane 25' feet each side of the northern driveway on Alamo. We will coordinate the construction of this area to accommodate school traffic. The city is responsible for up to \$35,000 of the cost.
- City staff has completed the initial review of the 2025 Firefighter Salary Study and it should come before the City Council on December 1, 2025.
- EDC Industry Luncheon is Thursday, November 20th at the Mallet Event Center beginning at 11:30am and ending around 1 pm.
- City Appreciation Dinner is Thursday, November 20th at the Mallet Event Center beginning at 6 pm and ending around 9 pm.
- I will be leaving the office on Thursday, October 23rd to attend the ICMA Conference in Tampa. I return to Dallas on Tuesday, October 28th, for the TML Conference in Fort Worth.
- The city has approved a request for a drilling permit located on our WWTP property on the northwest corner. They are building an access road and bringing in caliche for the pad site.
